Q3 We consider it is thoroughly evidenced by the BCCS and other supporting documents that significant green belt release is required in order to meet the Housing requirements of the conurbation, this need should be met by both Green Belt rounding and SUE's in order to meet the housing needs of the Authorities making up the BCCS.

Q5 We support the Green Belt Review.

We support Strategic Option 1A with a larger level of Green Belt Land release. This option raises less challenges to delivery overall. A flexible approach is however needed that also allows underused employment land that is no longer required to come forward to support the Strategy and bolster the overall supply. The levels of housing need are likely to increase further and therefore allocating and identifying more sites and safeguarding these for the future would be the most pragmatic approach.

Spatial Option H1 – Rounding off / Spatial Option H2 – Sustainable Urban Extensions.

We consider that a combination of the two approaches is required in order to best attempt to meet the increasing housing requirement. Many areas or land could be rounded off without impacting the main purposes of the Greenbelt and these would provide deliverable sites within the short to medium term. Larger SUEs are also needed but as identified these will take much longer in terms of delivery due to infrastructure requirements. Therefore a combination of the two approaches is therefore required.

Q15a Concern is raised in respect to possibility of exporting housing growth beyond the four Authorities. It is considered that this is unlikely to be achievable. Evidence already exists that other Authorities are not keen on this approach. For example Telford have already rejected taking growth in their Local Plan Examination to the west of the BCCs area and the Authorities to the east are all under pressure to accommodate Birmingham's requirement. It is considered therefore that the BCCs should be looking to accommodate their own requirement within the BCCs area. The best way to achieve this is by taking a flexible approach to accommodating the housing requirement. In order to do this a combination of rounding and large releases should be considered, also making use of redundant employment land, but taking care to only use this resource appropriately and not always in the first instance. Care needs to be taken to ensure that employment land levels are not depleted to such an extent as to create a shortage of employment land provision.

Q40 We support the use of the latest 2017 SHMA findings to set the housing target.
